Welcome to the CLIP High School Alternative Program. CLIP, which stands for Contracted Learning for Individual Pacing, is one of three high school alternative programs available in the Riverview School District. CLIP is the primary option available to 11th and 12th grade students who are searching for an alternative to the regular high school program and working in smaller class size settings. Since CLIP classes are typically held between noon and 6:00 p.m., it is possible for students to work, attend other training programs, or address other unique situations during the morning hours.

CLIP has been highly successful in graduating over 190 students in its 17 years of existence. Students from CLIP have moved on to have successful experiences in 4-year universities, 2-year community and technical colleges, apprenticeship programs, in addition to gainful employment. As a school that is aligned with the state standards and graduation requirements, all CLIP students must meet Riverview School District Graduation Requirements and pass the state required proficiency exams (HSPE) and the End of Course (EOC) assessments to qualify for graduation.

Mission Statement

The mission of CLIP is to provide an educational opportunity for students in grades 11-12 who are seeking an alternative way to earn a high school diploma.

Students must possess the following traits:

- ◆ Be a self-starter
- ◆ The desire and interest to study independently
- ◆ The ability to understand direction and follow through
- ◆ A dedication to complete daily assigned work
- ◆ A desire to earn credits toward graduation

Expectations

- ◆ Students of the CLIP program are required to spend 25 hours a week on their studies.
- ◆ Students are committed to engagement of critical thinking and their own education.
- ◆ Each CLIP student is required to attend the class two to ten hours each week.
- ◆ Students meet with their instructors weekly and need to maintain progress on their individual plan for graduation.
- ◆ Students must act in a respectful manner at all times.

Students will be considered for the program under the following circumstances:

- ◆ Students who are behind in credits in the traditional high school and may not be able to graduate with their class.
- ◆ Students who are not presently enrolled in any high school program.
- ◆ Students who want to progress at a pace commensurate with their skills, aptitudes, and motivation.
- ◆ Students who find that the traditional school setting does not meet their needs and want a different way to learn.
- ◆ Young people who have diverse needs and lifestyles or other obligations including employment, which makes full-time school attendance in the traditional high school setting difficult.
- ◆ Other reasons that are aligned with the program's mission.
